Cost of Living Allowance (COLA) 2024

- Council received a report regarding the 2024 Cost of Living Allowance (COLA) for information purposes. The report recommended a 3.6% increase to align with the Township's COLA Policy.

Final 2024-2027 North Huron Strategic Plan

- Council approved the final 2024-2027 North Huron Strategic Plan. The Plan sets the direction for the short-term and long-term based on feedback gathered from Council, staff, and community members. The 2024-2027 North Huron Strategic Plan can be viewed on the municipal website.

Maitland Valley Conservation Authority—Update on 2023 Workplan—Delegation Presentation
