# **INTRODUCTION**

The Township of North Huron is a municipality located within Huron County. North

Huron is a community of communities comprised of East Wawanosh, Blyth and Wingham and has strong rural roots and is home to approximately 5,000 people. The Township boasts excellent farmland, engaged volunteer groups, beautiful and rugged landscapes, and modern and productive agricultural businesses. Residents and visitors appreciate the plethora of services available in a Township that also offers a small, hometown appeal. The lure of



the Alice Munro connection attracts visitors from across North America and beyond to experience the history of the Township.



North Huron's new Strategic Plan charts forward a clear path for the Township, as we work towards our new vision for the future of our municipality: The Township of North Huron is a prosperous and engaged municipality that welcomes visitors, families, and residents through strong agriculture, development, culture, and tourism.

This Plan recognizes the importance of identifying attainable goals and a clear

path to achieving those goals. Over a three-month period, Council and staff worked in collaboration to develop the plan, with community members contributing throughout the

planning process by providing input to the vision, mission, goals, and actions contained within this document.



## How to Read this Plan

The Strategic Plan is composed of the following pieces that together create the framework:

**VISION** - An aspirational statement that provides a high-level outline of the Township's direction. It defines where we would like to see ourselves in the future.

**MISSION** - Defines what we do, for whom and why. It is our purpose statement.

**VALUES/ PRINCIPLES** - Operating principles and values that guide our conduct and actions as we implement our strategic plan.

**GOALS** - An aspirational statement specific to the six themes of the strategic plan, as follows:

- **Economy** encompasses business, housing, industry, tourism, agriculture, employment, growth, and jobs.
- **Community –** encompasses arts, culture, heritage and education.
- **Governance and Modernization -** encompasses community engagement, communications, accessibility, fiscal responsibility, accountability and internal development.
- Infrastructure encompasses roads, buildings and other capital assets.
- **Services** encompasses service areas including day care, health and social services and recreation.
- Environment encompasses air and water quality, land, waste and energy.

**ACTIONS** - These are the specific steps that will occur to reach the stated goals. Each goal has a clear set of actions with a list of intended outcomes (how the action will help the Township reach the goal), who is involved (collaborators that will need to participate in the action in order for it to be implemented), timelines and metrics (if applicable). Actions are listed as ongoing, short-term (2020), medium-term (2021-2022), and long-term (2023).

# **IMPLEMENTATION**

The Township will be responsible for reporting on progress at the mid-point of this Plan (between 2021-2022).

Staff reports will continue to identify alignment to the Strategic Plan during the term of the Plan by identifying which goal(s) and action(s) they support. The Plan is scheduled to be renewed in four years (2023).

It is recommended that the Township explore partnership opportunities with key stakeholders (e.g. Huron County, neighbouring municipalities, local community groups/organizations, etc.) as appropriate to support the implementation of this plan.
