ACKNOWLEDGEMENT OF RESPONSIBILITIES  The chance of an injury occurring can be reduced by carefully following instructions at all times engaging in activities. I, as parent/guardian of the Participant, have discussed the responsibility to obtain the instructions, rules and regulations of the Complex. Among these rules, the following age restrictions to the following facilities:  The fitness centre is not intended for use by children under the age of 14. Children under this age makes be supervised by a parent/guardian.  The courts are not intended for use by children under the age of 9. Children under this age must be supervised by a parent/guardian.  In the aquatic centre children 10 and under, not directly supervised by a parent/guardian, are subject height requirement (minimum of 48 inches) and/or a swim test. Children under 7 must be accompated by a person 14 years or older, who must remain in arms reach at all times.  In the arena it is recommended that children under 12 be accompanied by a parent/guardian. CSA helmets are recommended for all participants.	bey al s apply nust ct to a
