### **November 7, 2022 Regular Council Meeting**

#### *More Homes Built Faster: Ontario's Housing Supply Action Plan 2022-2023*

- Council passed a resolution to send a letter to the Province of Ontario expressing concern with the lack of public consultation and the potential negative impacts that Bill 23, the More Homes Built Faster Act will have on small, rural municipalities.

#### *Resolution of Support - Municipality of Huron Shores - Opposition to Bill 3*

- Council passed a resolution of support for the Municipality of Huron Shores' resolution regarding their opposition to Bill 3 - the Strong Mayors, Building Homes Act.

#### *Retirement Presentation - Dave Cook, Manager of Recreation Facilities*

- Council congratulated Dave Cook on his retirement and thanked him for his many years of service to the Township.

#### *Consent Application C89-2022 (75 Alfred Street West)*

- Council passed a resolution to support the Consent Application C86-2022 with the conditions set out in the Huron County Planning and Development Report presented by Hanna Holman, Planner.

#### *Renewal of the Child Care Service Provider Agreement - Huron County*

- Council approved the renewal for the Child Care Service Provider Agreement with Huron County for a three-year term. This agreement allows for the flow of funds from the Canada-Wide Early Learning and Child Care Program.



#### **November 7, 2022 Regular Council Meeting**

##### *Renewal of Lease Agreement for Galbraith Park - Maitland Valley Conservation Authority*

- Council authorized the renewal of a Lease Agreement with Maitland Valley Conservation Authority for the Turnberry Floodplain Conservation Area (Galbraith Park) for a three-year term.

##### *Transfer of Parks and Trails*

- Council directed staff to implement changes to the organizational structure of the Township in order to transfer responsibility for Parks and Trails from the Public Works and Facilities Department to the Recreation and Community Services Department. The reorganization will increase the efficiency of operation in relation to the maintenance of Parks and Trails.

##### *Blyth Campground Pilot Project Year-End Update*

- Council directed staff to continue to operate the Blyth Campground as operated during the 2022 pilot project.

##### *Parking By-law Update*

- Updates to the North Huron Parking By-law were approved, and Council directed staff to submit the Parking By-law to the Ministry of the Attorney General for approval of the set fines schedule. This update will continue to reduce complications for enforcement of parking provisions within the Township.

##### *Appointment of Huron County Fire Coordinator*

- Council approved the appointment of North Huron Deputy Fire Chief Chad Kregar as the Fire Coordinator with the Huron County Mutual Fire Aid Association for the 2022-2026 term.

##### *Requests for Financial Support for 2023*

- Council received requests for financial support from the Huron County Plowmen's Association, the Wingham and District Horticultural Society, the Elementary School Fair, and the United Way Perth-Huron. Staff were directed to include the financial requests as part of the 2023 budget deliberations.

##### *Community Policing Advisory Committee – Police Services Act*

- Council passed a resolution to implement a Community Policing Advisory Committee under the Police Services Act to support the governance of the OPP services in the Township until such time as the Community Safety and Policing Act is in force.

#### **November 21, 2022 – Inaugural Council Meeting**

The 2022-2026 Members of Council provided their Declarations of Office and were officially sworn in at the Inaugural Council Meeting held on November 21, 2022. Now that all the Declarations have been duly signed, the 2022-2026 Term of Council is deemed to be formally organized. Congratulations to all of the Members of the Council of the Township of North Huron.
