Tender Results for Howson Dam Decommissioning

Council received and reviewed the tender results for the decommissioning of the Howson Dam.
 Council awarded the decommissioning of the Howson Dam to Roubos Farm Services Limited in the amount of \$1,036,777.60. The project will be funded though the Ontario Community Infrastructure Fund (OCIF), the Howson Dam Reserve fund, and the Westario Reserve Fund.
 There will be no impact on taxation as a result of the project.
