## **Compliance Report – Candidate's Financial Statements**

The *Municipal Elections Act* requires all 2022 Municipal and School Board candidates to file a Financial Statement (Form 4) for all contributions and incurred expenses during the campaign period. The deadline for filing financial statements for the reporting period ending January 3, 2023 was on or before 2:00 PM, March 31, 2023. A candidate who missed the filing deadline was able to file within a 30 day grace period, provided that a \$500.00 late filing fee was paid to the municipality.

The *Municipal Elections Act* stipulates that candidates whose campaign contributions and total expenses are greater than \$10,000 must have their financial statement audited and submit the auditor's report to the Clerk along with their financial statement. The auditor's report shall be prepared by an auditor licensed under the *Public Accounting Act*, 2004.

Section 88.23(4) of The *Municipal Elections Act* requires the Clerk to make available to the public a report setting out all candidates in an election and indicating whether each candidate complied with Section 88.25 of the Act. In accordance with Section 88.23(5) of the Act, the report shall be made available on the website as soon as possible after April 30th in the year following a regular election.
