## The Corporation of the Township of North Huron

### By-law No. 90-2024

---

#### Being a by-law to establish fees and charges for the Township of North Huron

---

WHEREAS Section 391 (1) of the Municipal Act, S.O. 2001, Chapter 25, provides that a Municipality or a local board may pass by-laws imposing fees and charges for services or activities provided;

AND WHEREAS the Council of the Corporation of the Township of North Huron deems it expedient to establish fees and charges in the Township of North Huron;

AND WHEREAS the Council of the Corporation of the Township of North Huron is desirous of providing services and activities through a user pay and cost recovery model where possible;

NOW THEREFORE, the Council of the Corporation of the Township of North Huron enacts as follows:

1. That the Corporation of the Township of North Huron hereby adopts the fees in the attached Schedules to this By-law.
2. That this By-law be cited as the "Fees and Charges By-law".
3. That any schedule of this By-law can be amended by resolution or by-law of Council and that the amended schedule shall form part of and be included in the Fees and Charges By-law.
4. That all fees and charges are due and payable at the time the service is provided. If the fees and charges or any portion thereof remain unpaid after the due date, interest at the rate of 1.25% shall be charged, and again on the first of each month thereafter until the account is paid in full.
5. That HST will be charged where applicable.
6. That all fees and charges payable under this by-law including taxes, interest and collection costs constitute a debt of the person or persons charged and if unpaid, where permissible, shall be added to the tax roll for any property in the Township of North Huron owned by such person or persons and may be collected in the same manner as taxes.
7. That in the event any particular provision or provisions or part of a provision in this by-law is found to be void, voidable or unenforceable for any reason whatsoever, then the particular provision or provisions or part of the particular provision shall be deemed severed from the remainder of this by-law and all other provisions shall remain in full force.
8. That any other fee in any by-law inconsistent with these fees and charges are hereby repealed.
9. That this By-law shall come into full force and effect January 1, 2025.
10. That By-law No. 81-2023, By-law No. 47-2024 and By-law No. 52-2024 be hereby repealed.

Read a first and second time this 2<sup>nd</sup> day of December, 2024.

Read a third time and passed this 2<sup>nd</sup> day of December, 2024.
